

CO-ED WATER VOLLEYBALL CONTEST

When: Saturday, July 27, 2024 @ 10:00 AM; Games begin at 10 AM – all teams must arrive by 9:45 AM

Where: In the water in front of The Anchorage (next to the former Harbour House restaurant)

Fee: \$30 per team when registered by 6:00 PM on Wednesday, July 24, 2024; \$40 per team on the day of the event; if not preregistered, arrive between 9:00 - 9:30 AM to sign up; NO REGISTRATION AFTER 9:30 AM on Jul 27, 2024

Rules & Regulations

1. Being a co-ed contest, each team must have a minimum of 2 female & 2 male players. Teams may have between 4 & 6 players on the court during the games.
2. Court boundaries will be marked with rope supported on top of the water by water noodles. Referee’s calls are final. Each team will be required to supply 2 line judges for a match.
3. This is a single elimination tourney. Weather permitting, all teams will play a minimum of 2 matches (teams that lose their first match will play a consolation game); each match will consist of two games to 25 points each. If each team has won one game, a third game to 15 points will be played. Rally scoring will be used for all games.
4. A coin flip will be used at the start of the match and if a third game is necessary. The team that wins the coin toss may choose either side or serve; these will be switched for the second game.
5. No personal alcoholic beverages may be brought to the event, per the Indiana state law!
